## G.O.A.L. PROGRAM – HOCKEY INITIATION



Glacier Youth Hockey Association is pleased to introduce G.O.A.L., a FREE on-ice youth hockey program presented by Glacier Ice and Snow Arena as part of our commitment to the development of youth hockey.

G.O.A.L. has been created to offer selected youngsters the opportunity to experience the excitement of hockey without the cost of purchasing equipment. This program is designed for boys and girls ages 4 to 10 years old with no prior hockey playing experience. This FREE 4-week ice hockey program will introduce

the exciting sport of hockey to kids while teaching life experiences of team-work, sportsmanship, and self-confidence as a child develops through athletic participation.

G.O.A.L. provides beginner players the opportunity to learn the basic skills of ice hockey through four 40-minute sessions at Glacier Ice. Participants will learn forward strides, stops/starts, turns, crossovers, stickhandling, passing, and shooting in a fun environment! We will encourage participants to actively partake in drills geared towards their skills development. Once the 4-week session is complete, there are other hockey programs available for continued development.

Participants of G.O.A.L. will receive on-ice instruction by USA Hockey certified coaches, as well as complimentary equipment on loan. Participants will also receive an official G.O.A.L. hockey jersey to keep as a souvenir.

*\*Glacier's G.O.A.L. program is intended for skaters with some skating experience. Children currently participating in a league or pre-hockey program are not eligible. Graduates of G.O.A.L. may not register for additional 4-week sessions.*

PARTICIPATION AGREEMENT, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND ASSUMPTION OF RISK  
By signing this document you may be waiving certain legal rights, including the right to sue

TO: The Arena, Arctic Fun Inc. d/b/a Glacier Ice and Snow Arena, their owners, officers, directors, agents, employees, and/or representatives  
ASSUMPTION OF RISK: I am aware that ice-skating involves certain inherent risks, dangers, and hazards, which can result in serious personal injury or death. I am also aware that ice skating arenas contain dangers to the ice-skating public. As such, I hereby freely agree and accept any and all known and unknown risks of injury while participating in ice skating activities. I further recognize and acknowledge that the risks inherent in the sport of ice-skating can be greatly reduced by taking lessons, abiding by the Skater Responsibility Code (now known as "Your Responsibility Code") and using common sense.

RELEASE AND WAIVER OF CLAIMS AGREEMENT: In consideration of allowing me to participate in the leagues' ice-skating activities at the arena, I hereby agree as follows:  
1. To waive any and all claims  
2. To release the arena from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer, as a result of my participation in the activity described in this agreement, due to any cause whatsoever, including the negligence or breach of contract on the part of the arena and/or league in the operation, supervision, design, or maintenance of the arena.

ARBITRATION: In further consideration of allowing me to participate in the league's ice skating activities in the arena, I hereby agree to submit to binding arbitration and any and all claims which I believe I may have against the arena and/or league arising from the league's activities at the arena. The arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings.

Arbitration shall be commenced within one (1) year from the date on which the alleged claim first arose. Further, the arbitration shall be held in the town where the arena is located, unless otherwise mutually agreed to by all parties. The submission to the American Arbitration Association shall be unlimited and any court of competent jurisdiction may enforce the arbitration award.

BINDING EFFECT OF AGREEMENT: In the event of my death or incapacity, this agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives.

ENTIRE AGREEMENT: In entering into this agreement, I am not relying upon any oral or written representations other than what is set forth in this agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE ARENA AND THE LEAGUE.
